IN 28 YEARS THE PROGRAM HAS EXPANDED TO A CAPACITY TO HOUSE 26 FAMILIES PER DAY WITH EXPANDED FAMILY SERVICES TO AN ADDITIONAL 18,709 PEDIATRIC PARENTS SEEKING SUPPORT PER YEAR IN OUR FAMILY ROOM PROGRAM AT DUKE CHILDREN'S HOSPITAL. HOWEVER, THE EXPONENTIAL GROWTH (SINCE 2000) OF DUKE CHILDREN'S HOSPITAL HAS CONTINUED TO DRAMATICALLY INCREASE THE DEMAND FOR SERVICES THAT SUPPORT DUKE'S GOAL OF FAMILY CENTERED CARE; THE DEMAND FAR EXCEEDS THE HOUSING COMPONENT OF OUR PORGRAM'S CURRENT CAPACITIES.
